

IMPORTANT NOTICE TO ALL POLICYHOLDERS AND CREDITORS OF THE MALTESE BRANCH OF INDEPENDENT INSURANCE COMPANY LIMITED (IN PROVISIONAL LIQUIDATION)

The Joint Provisional Liquidators of Independent Insurance Company Limited (In Provisional Liquidation) ("Independent"), Mr. Dan Schwarzmann and Mr. Mark Batten of PricewaterhouseCoopers LLP of Plumtree Court, London, United Kingdom are now in a position to update further the creditors of Independent's Maltese branch ("Independent Malta") on the progress that has been made regarding a dividend payment.

In their letter to all creditors dated 31 July 2006, the Joint Provisional Liquidators referred to the fact that a number of claims had not been brought to a satisfactory conclusion resulting in a delay to the payment of a dividend. These claims issues have now been resolved and, as a result, the Joint Provisional Liquidators are now planning to make a dividend payment to all Independent Malta's creditors who returned a signed claims agreement form to Micallef Insurance Agency Limited before the claims agreement deadline in 2006.

Quantum and timing of the dividend payment

The Joint Provisional Liquidators expect to be able to pay a 100% dividend to you or your broker by 20 July 2007.
