Circular on Third-Country Markets considered as Equivalent to a Regulated Market under EMIR Regulation (EU) N° 648/2012 the European Market Infrastructure Regulation ('EMIR' or the 'Regulation')

Introduction

This Circular is being addressed to all market participants, particularly entities who enter into derivative contracts and which fall within the scope of EMIR, namely, financial counterparties ('FCs') and non-financial counterparties ('NFCs') as defined under EMIR. This Circular should be read in conjunction with the Regulation, its Delegated Regulations and previous Circulars issued by the Authority, as the case may be.

Overview

The Authority wishes to formally notify market participants that the European Securities and Markets Authority ('ESMA') has, published a <u>list</u> of third-country markets. The markets established in a third country, as outlined in the attached document <u>and table provided in Annex 1</u>, have been considered as equivalent to a **regulated market** in the Union in accordance with Article 2a of EMIR and for the purposes of Article 2(7) of this Regulation.

The table provided in Annex 1 is published by ESMA in accordance with Article 2a(3) of EMIR. Its aim is to facilitate access to the relevant information for the purpose of the OTC derivative definition under EMIR; whereas, from a legal perspective, stakeholders are invited to refer to the various Regulations covering markets established in a third country for the details on the applicable regime.
